Ongoing programs:

*Research Programs – In 2012, the Foundation Fighting Blindness directly funded \$1,829,940 in innovative retinal eye disease research at universities and hospitals across Canada. Funds are awarded through an annual peer-reviewed grant competition and recommendations are subject to the approval of the Board of Directors.

*Research Collaboration – In 2012, the Foundation Fighting Blindness committed \$411,986 to research collaborations with the CIHR, Canada's premier health research funder. The Foundation Fighting Blindness contributed a portion of the funding for three multi-million dollar projects translating scientific knowledge into treatment. The projects are approved by CIHR review panels.

*Education and Awareness – in 2012, the Foundation Fighting Blindness committed \$344,607 to education and awareness programs for people living with retinal degenerative diseases, their families and the general public. We provided regular research new coverage as well as an array of print and electronic materials on research and standards of eye disease care, and host a series of education conferences on vision research in centres across Canada.

New programs:

In 2012, the Foundation Fighting Blindness began funding its first human clinical trial of an ocular gene therapy in partnership with the Canadian Institutes of Health Research and other non-profit funders.


