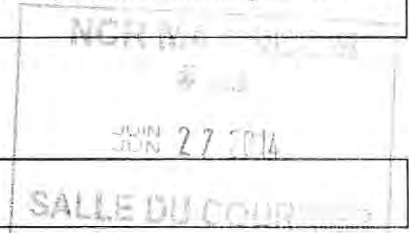

Ongoing programs:

Research Programs – In 2013, the Foundation Fighting Blindness directly funded \$2,022,330 in innovative retinal eye disease research at universities and hospitals across Canada. Funds are awarded through an annual peer-reviewed grant competition and recommendations are subject to the approval of the Board of Directors.

*Education and Awareness – in 2013, the Foundation Fighting Blindness committed \$342,556 for education and awareness programs for people living with retinal degenerative diseases, their families and the general public. We provided regular research new coverage as well as an array of print and electronic materials on research and standards of eye disease care, and host a series of education conferences on vision research in centres across Canada.

New programs:

In 2013, the Foundation Fighting Blindness undertook an exhaustive audit of its research programs, evaluating the impact of its research investments over the past 40 years. As well, the Foundation launched a new partnership with the Canadian Institutes of Health Research Proof of Principle program to support the development of potential new treatment drugs from retinitis pigmentosa.
